



Blue Blood Poker Privacy Notice

Your privacy is important to Blue Blood Poker. This privacy statement provides information about the personal information that Blue Blood Poker collects, and the ways in which Blue Blood Poker uses that personal information.

Personal information collection

Blue Blood Poker may collect and use the following kinds of personal information:

- information that you provide using for the purpose of registering with the website (I.e details on your application form);
- information that you provide for the purpose of subscribing to the website services (including a forum or emailing list); and
- any other information that you send to Blue Blood Poker.

Data Stored in Cookies

We use a cookie called "JSN_Profile". This cookie is used on the main homepage of our website. The only data collected is from your web browser is the Tab Status. These cookies are used to store text values for all the JSN EasySlider functions to make sure that JSN EasySlider runs smoothly. Cookies will be stored in a user's web browser directory while a user browses a website and will only be removed when users clear cookies.

Using personal information

Blue Blood Poker may use your personal information to:

- administer this website;
- personalize the website for you;
- enable your access to and use of the website services;
- publish information about you on the website;
- send to you products that you purchase;
- supply to you services that you purchase;
- collect payments from you (note that membership is free but you maybe required to purchase merchandise such as official sweatshirts etc; and
- send you marketing communications.

Where Blue Blood Poker discloses your personal information to its agents or sub-contractors for these purposes, the agent or sub-contractor in question will be obligated to use that personal information in accordance with the terms of this privacy statement. In addition to the disclosures reasonably necessary for the purposes identified elsewhere above, Blue Blood Poker may disclose your personal information to the extent that it is required to do so by law, in connection with any legal proceedings or prospective legal proceedings, and in order to establish, exercise or defend its legal rights.



Securing your data

Blue Blood Poker will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information. Blue Blood Poker will store all the personal information you provide.

Cross-border data transfers

Information that Blue Blood Poker collects may be stored and processed in and transferred between any of the countries in which Blue Blood Poker operates to enable the use of the information in accordance with this privacy policy. In addition, personal information that you submit for publication on the website will be published on the internet and may be available around the world. You agree to such cross-border transfers of personal information.
